
# MPD Updates 2025

- 2025 TSA Gold Standard Award in February (17 categories of security and emergency preparedness)
- Real Time Crime Center (RTCC) up and running.
- CALEA (The Commission on Accreditation for Law Enforcement Agencies) annual audit completed with no discrepancies February 2025.
- 2025 SEPP (Security and Emergency Preparedness Plan) approved by GDOT.



- 15 Community events hosted to include Career days at local schools and HBC colleges, steering wheel lock giveaways, coffee with a cop.
- Finalizing General Order to allow MPD to utilize the new City of Atlanta Diversion Center.
- EPU (Emergency Preparedness Unit) beginning audits/security inspections of rail/bus facilities began in March 2025 (Congressionally Directed Spending (CDS) grant application submitted).
- Puerto Rico recruitment trip completed March 9<sup>th</sup> – 12<sup>th</sup>. Second phase to finalize hiring scheduled for late April. Currently working 37 applications.

# MPD Hiring YTD 2025



- **Academy length went from 11 weeks to 21 weeks in 2025.**
- **15 officers in various stages of police academy training.**
- **Currently 2 officers waiting academy 4/21 and another 3 schedule for 7/7 as of 4/10.**
- **New COMP package has incentivized 13 officers that left MPD in 2024 to re-apply/return in the first three months.**
